LHV operates exclusively in SF Bay Area, working with low income families and their children ages 2-5. COVID created new challenges for our organization requiring us to pivot from a home visitation program. Our investment in helping parent find

In our program, the child's first teachers, their parents, continue in their roles of the educator but instead of the learning being adult led, it is child led. This is a significant change in the relationship that parents have with their child, but an essential one. To help our parents make this change, our family coordinator is key. Not only is she responsible for the bi-weekly delivery learning materials to the home but maintaining a relationship with the parents. During her visits with the parents, she hears about each child's exploration and mastery. She answer questions that may have come up during the learning session. Finally she is responsible for all supportive materials development which include the video sessions regarding activity learning ideas, surveys and intake activities are done by the family coordinator as well. This close relationship is reason for our high level of parent engagement.

Train and support community volunteers and parents to foster learning in a child-directed play program: Each parent and community volunteer is trained on the adult's role in child-directed play. Training includes both online training and in-person training. Each adult is provided with basic teaching materials which support the mastery of numeracy, letter recognition, color recognition and shape recognition. Ongoing training is provided through Classtag and in person visits by our family coordinator.

Support literacy through the building of the child's home library: Such a huge part of child's development ages 2 - 5 is language acquisition and one of the best tools for exploring the world of words and the world itself is reading. We provide a core set of books for all of our participants and then provide 2 books each month to add to their library through out the program. Parents use these books to read to their children nightly.
